Ms. Trotter took over for Mr. Kinsel. The auditors are scheduled to come to the office in December. Ms. Taglia-Polak has begun adding documents to the portal for the auditors. Right now, all that is left to do is wait until the fiscal year ends.
- 6. JP Morgan Fee Credit Program Extension-JP Morgan sent out notice the Fee Credit Program was extended six (6) months through June 30, 2026, it is 30% of investment fee.
- 7. Letter of Engagement, Lark Janes, Professional Accounting Services-Ms. Janes' new monthly rate is \$3,420.00. It was previously \$3,350.00. Motion by Mr. Kiszkiel, seconded by Mr. Sacco to accept and approve the rate increase and letter of engagement for Ms. Janes. Motion carried with members voting as follows: Mr. Dorey, Yea; Mr. Brock, Yea; Mr. Sacco, Yea; Mr. Kiszkiel, Yea; Mr. Lancaster, Yea.
- 8. Entities that Boycott Israel Memo-Mr. Klausner's office provided a memo. Mr. Sendra reviewed funds cannot invest in companies who are actively boycotting Israel. If the Fund is already invested in a company who is boycotting Israel, then it must divest within twelve months. Mr. Cole would notify the Fund if any of the investments were boycotting Israel. Burgess Chambers and Associates works with compliance. Additionally, contracts entered or renewed on or after July 1, 2025, must contain a provision that allows for termination of the agreement if a company or other entity is found to be engaged in a boycott. Ms. Taglia-Polak has already sent the memo to Mr. Cole and Ms. Chaviano at Burgess Chambers and Associates.
- *9. Reduction of Monthly Pension Due to Age 65 Supplement, Police Officer Myron Palmer-This item was approved under consent.

- *10. Termination Refund/Rollover or Vested Termination, if Eligible, Police Officer Mark Rendel-This item was approved under consent.
- 11. Stanley v. City of Sanford Memo-A firefighter, Stanley, from the City of Sanford received a Non-Line of Duty Disability before her normal retirement. The statute requires the employee stay on City health insurance if they worked 25 years until the age of 65. This would be paid for by the City. Before Stanley could be approved for disability the City of Sanford changed its policy to the City pays for health insurance for only 24 months instead of until age 65. There was discrimination. Stanley sued and it went to the Supreme court. It was an ADA claim. She was no longer able to perform the functions of a firefighter, under ADA you must be able to perform, it was directly contradictory.
